Full regulation safety equipment

\* To drive a personal watercraft in Croatia one needs to have a boat driving permit with them when operating the personal watercraft.

It is illicit to operate a personal watercraft without a license.

If the person does not have the license, it is possible to obtain one while in Croatia. We do recommend obtaining the license in your home country, however you can always contact us for the additional arrangements of obtaining the license.

**Expense Management** 

APA (Advance Provisioning Allowance) min. 7500 € is used to cover following costs, but not limited to: additional fuel for the main engine and generators; fuel for tender and water sports equipment; food and beverages for the guests; berthing dues and other harbour charges including pilots' fees, local taxes, divers' fees, customs formalities, charges for waste disposal, charges for water and electricity taken from shore; shipping agents' fees where applicable; guests' personal laundry; hire or purchase costs of any special equipment placed on board at the guest's request, shore-side transport and excursions, national park entrances and other costs initially not included in charter price, for services requested by the guest during the charter. Please note: APA is to be paid in cash on board or as a wire transfer to shipping agent's account. Should APA be paid as wire transfer, shipping agent's commission will be deducted from the APA. If APA doesn't cover complete costs, guest will pay exceeding amount on board in cash. If costs made on charter are less than amount given as APA, amount that was not spent will be returned to the Client at the end of the voyage. APA does not include tip for the crew.
